1. INTRODUCTION

1.1. Purpose of this document

The Roaster & Retailer Reporting is anchored in <u>GCP's Terms of Participation</u> for members and has recently been reconfirmed as prioritized action and concrete ask in <u>GCP's Call to</u> <u>Action to Collectively Address the Coffee Price Crisis</u>. On an annual basis our roasters and retailer members are therefore encouraged to voluntarily report on their overall green coffee volumes, as well as their volumes of sustainable coffee* purchased and delivered to your factory (by origin), starting with calendar year 2018. Reporting on earlier years is strongly encouraged.

This document aims at guiding each user through the software in a step-by-step approach to ensure a smooth software experience for the users and to facilitate easy and straightforward reporting with no technical issues or misunderstandings in terms of the expected information to be provided by each user.

As a user, we encourage you to follow the steps described on the following sites to deliver the agreed reports of your company as your participation in the GCP deliverables 2025.

1.2. Further Support

This document basically provides all information necessary to guide you through the software and the reporting process. However, when working with software, there is always the chance for issues or questions, which might not be considered in such a guideline document. For those cases and in any occasion of technical issues not considered/described in this document, please do not hesitate to e-mail to GCP support team under the address mentioned below:

When e-mailing, please provide your full name and email address you provided us for the reporting system. This helps us to identify the respective user in the reporting system in order to provide faster support.

1.3. Requested information.

As agreed amongst the GCP membership, the Roaster & Retailer reporting is supposed to consist of the following information:

o Total volume of green coffee purchased in the last calendar year

o Proportions of purchased volumes by:

o Subdivision by countries and agreed certificates/schemes

In order to create a first analysis based on more reliable and calculable information, we also have to ask for volumes from the previous year(s) in the first report according to availability. Therefore, we enable you to report your information back to the year 2018, encouraging you to report accordingly.



1.4. Data security & confidentiality statement

The Global Coffee Platform is aware of its responsibility within the scope of its social commitment for a careful handling of your data.

The data you enter on this platform is therefore transmitted to us via secure way of transport and is only stored locally on our own systems. Data is not stored in the cloud. The information is also evaluated by our locally installed Business Intelligence System. Access to this platform is only granted to those Global Coffee Platform employees who are obliged to maintain confidentiality and who are working on this project, as well as to a pre-selected and identified group of end users, such as you. Each end user can see only the information they enter.

The information entered is aggregated by the system. The aggregated data is only made available to all end users if at least five end users have provided information regarding the same country. This ensures that the aggregated data does not allow conclusions to be drawn about individual end-users who have made their data available.

The platform is only made available for the duration of the reporting phase. Once the reports have been compiled, the system is taken out of operation and the information is securely archived.

By using the platform and entering your information, you give your consent that the information may be processed for this purpose and in this way.

2. FIRST STEPS

2.1. Prerequisites - Before log-in

Identify your user.

Before logging in, you will need your user credentials. In order to get your credentials, please identify a person within your company, having the mandate to provide the requested information in the name of your company.

This person will be the contact address for GCP with regards to this reporting activity and will get her/his own credentials sent to her/his email address by our support team.

Please note: You will not be able to create a user in this reporting system by yourself.

2.2. First steps

2.2.1. The Log-in screen

Once you have been provided with your user credentials and the link to the reporting system by our support team, you will be able to log in. As a very first step, we strongly recommend you change your password to your personal one (see step 2.2.3). The steps below will explain you how to change your password.

2.2.2. The Overview screen.



After first log-in, the overview screen looks pretty empty as no report has been entered yet. According to the information classification given in these reports, you as a user can only see your own reports. The bullets below explain the structure of the screen:

- 1) Top ribbon, showing your position in the system structure and menu items.
- 2) Admin menu, here you can change settings and password (recommended after first login)
- 3) Create new, here you can create a new report.
- 4) (not shown here) **Back**, you will find a "back" button in the top ribbon (left side) once you leave the overview screen.
- 5) **Sync** this button is important, as it transfers all data provided to the server. The reported data you provide to the system will remain saved locally in the client on your computer until the sync button is being clicked. Once this button is clicked, your report is and gets synchronized to the GCP server.

Please note: You will not be able to change or correct any information after clicking the "Sync" button. In case you clicked this button unintentionally, please contact the support to delete your report. This means, you will need to re-submit your report.



2.2.3. Change your password.

We strongly recommend that you change the password provided by our support to your own personal password. For changing your password, please follow the steps below:

- 1) Click on the "admin menu button" (2)
- 2) Click on "Change password" and follow the instructions on the screen.

3) Reload the browser window and log back into the system, using your new password.



3. REPORTING PROCEDURE

Creating a report – Step by step

After changing your password, you are ready to create the first report. Make sure you have complete data ready for the reporting year as you cannot save the report in between; you must fill in all the data in one session.

If you are ready with the data, please follow the steps below to create your report.

3.1. Create new report: In the "Overview" screen click on **"Create new report"**



3.2. Choose reporting year and fill in total volume.

You will find a new form, asking to choose the calendar year you want to report on and the total purchased volume for that particular year.

After filling the form, start the proportion section by clicking on "create".

Remember: If this is your first report, you are encouraged to create a report for the previous years, you can only create a report for one year at a time. For each year, you will have to create a new report **(step 1)**.

Principle:

Per country you can also add entries with multiple certificates at a time, allowing you to claim volumes with multiple certifications at the same time. **Please only** provide multiple certificates for one entry if this particular volume from this particular country was purchased **under all chosen certificates**.

You will receive an error message if the total volume for the country doesn't matches the sum of proportions under different schemes.
